BILLING PROCESS

- Good news! We are continuing to keep our dockage at the 2008 rate: \$50 per foot and \$55 per foot for boats over 8 feet wide. A deposit of \$200.00 is required to reserve your slip for 2010.
- The deposit should be a check or money order mailed to the above address with the registration form completely filled out. We can also process your credit card (see pg.2).
- You may make installment payments on the balance anytime between now and May 1, 2010. Entire balance is due by May 1st unless you are already launched, in which case it should already be paid in full. Your boat will not be assigned a slip if there is an outstanding balance.
- Any slips and hoists not reserved by Feb 15, 2010, or not fully paid by May 1, 2010, will be offered to the next boater on the waiting list.
- We reserve the option to use your slip if your boat is out of the water for any reason.
- Please be sure that your bilge pump is operational. Boats that are in danger of sinking will be pumped (\$50) and may be hauled out (\$100). Owners will be notified and billed.
- Because of insurance and Coast Guard regulations gasoline transported on a dock must be in an outboard gas TANK — no "jerry" cans on the docks please. We sell ethanol-free, marine-grade gasoline in 89 and 93 octane. If you want to bring your own "jerry" cans of gasoline from elsewhere, you must bring your boat to the gas dock for filling.
- Owners of trailers left on Marina property will be charged \$10 per day.

If you have any requests for slip assignments, please indicate them on your application. We will do our best to accommodate you.

**THE OWNER OF THE BOAT IS THE PERSON WHO IS RESPONSIBLE
FOR ALL CHARGES INCURRED.**

Dock slips are available for \$50 per foot. Boats over 8-feet wide are \$55 per foot.

Boat length is what is stated on the registration; check to be sure you are not overpaying. If your boat has a fractional length (i.e. 21.5 feet), please state so. ***Do not round up or down.*** If the lengths listed on your reservation form or registration do not appear to correspond with the physical length of your boat, we reserve the right to measure your boat and charge accordingly.

Jet ski slips are available for \$400. A limited number of jet ski ramps are available for an additional \$375.

Appropriately sized boat hoists will be available for \$325 each. If using the early pay option, hoists must be paid in full in addition to the dockage fee.

We recommend 3/8" nylon mooring lines for boats up to and including 16', and 7/16" nylon for boats up through 21'. We recommend 1/2" nylon for boats over 21'. We sell mooring lines if you need them. Ski ropes, dog leashes, Venetian blind cord and clotheslines are NOT suitable for mooring. They not only put your boat in jeopardy, but also endanger the boat moored next to yours.

All boats must be tied at the bow and at **both** sides of stern. If you change boats for whatever reason you must notify the Dockmaster and submit the new NY registration number.

We cannot be responsible for loss or damage to your boat. We recommend that you obtain insurance.

Dockage Agreement

In consideration of the provision by Mayer's Marina Inc. hereinafter called Mayer's, a New York Corporation, located at 7 Lake Road, Webster, NY, of the dock space specified above I agree to pay herewith the season rate specified and to comply with the following terms and conditions:

1. I agree to keep only the boat stated below within the space designated. No part of the season rate is refundable. Neither this agreement nor the space designated is transferable without permission.
2. I agree to dock my boat in a seamanlike manner. In doing so I agree to use nylon rope at least 3/8" in diameter. My boat shall be tied securely at the bow and at both sides of the stern. Boats not tied up in this manner shall be retied by Marina staff at extra cost or removed and placed in storage at the owner's expense. If in the judgment of Mayer's my boat shall in any way be constitution a hazard to other boats docked, and if I am informed of that fact and fail to promptly make whatever corrections are necessary; or if Mayer's is unable to contact me, I agree that Mayer's may make such corrections as it deems best at a cost which I further agree to pay.
3. In consideration of the rental at which the dock space is let, I agree that Mayer's shall not be liable for any damage to my boat, to any car parked on its premises, or for theft or vandalism.
4. While I understand that dock customers may use the Mayer's launching ramp at no cost throughout the season, Mayer's reserves the right to limit the number of launches or to charge for launches if it deems the number of uses is excessive.
5. I agree not to leave a wake while navigating within the anchorage or within 200 feet therein.
6. I further agree not to smoke, or use "jerry" cans to refuel my vessel, or to employ any other flammable devices at the docks, such as barbecue grills or deep fryers.
7. In the event that I do cause damage to any other boat, property or any of Mayer's facilities in any manner, I agree to make full monetary restitution and I further agree to hold Mayer's harmless from any and all damage I may cause in any manner to the boats or property of others.
8. I agree not to hold Mayer's liable for any damage that may occur to my boat or property or person from any cause whatsoever. I agree that any violation by me or anyone acting on my behalf, of the conditions stated, shall constitute immediate termination of the agreement without refund.
